How Different Will the World Come Out of the Current Financial Crisis?



polečnost Comenius ve dnech 24. až 26. března uspořádala již sedmnácté mezinárodní Evropské Bankovní & Finanční Fórum. Akce každoročně poskytuje prostor pro setkávání předních představitelů centrálních bank, mezinárodních finančních institucí, bankéřů a finančníků, vysokých činitelů státní správy a dalších odborníků. Nabízí jim možnost diskuse nejenom o aktuálních problémech a tématech hýbajících světem financí, ale i jejich dopadech v celospolečenském měřítku. 400 účastníků z celého světa se tak v zájmu médií věnovalo ústřednímu tématu – a tím je dopad finanční krize a způsob, jakým změní náš život.

Dopoledne prvního dne konference bylo věnováno tzv. vizionářskému panelu, který tematicky zastřešuje celé fórum, a dále pak centrálním bankám. Tyto dva panely tvořily jeden z vrcholů celého fóra, při kterém byly nejvíce diskutovány dopady finanční krize v celosvětovém měřítku. Nejvíce očekávaným mluvčím byla francouzská ministryně hospodářství, průmyslu a zaměstnanosti Christine Lagarde, jejíž vystoupení nakonec muselo být z důvodů cesty s předsedou vlády Francoisem Fillonem do USA nahrazeno videopříspěvkem. Na straně 26 přinášíme exklu-

zivní materiál v podobě části jejího projevu. Jako již tradičně se u řečnického pultu vystřídali guvernéři centrálních bank z Čech, Slovenska, Srbska, Arménie a USA. Největší pozornost vyvolalo vystoupení Charlese Evanse, prezidenta Federální rezervní banky v Chicagu. V něm po popisu některých projevů krize v českém prostředí, vlastně doposud opomíjených - jako například dopad na univerzitní vzdělávání v důsledku krize studentských půjček, popsal řadu programů, které FED připravil k posílení likvidity na finančních trzích.

Právním a finančním těžkostem krachů a revitalizací postižených společností a možnostem využití IT v době krize se věnovaly dva odpolední panely. V posledním bloku vystoupili odborníci z oblasti informačních technologií. Všichni se shodli, že sofistikované systémy mohou firmám i finančním institucím významně pomoci jak při řešení současné složité situace, tak i v běžném každodenním provozu, a že se jednoznačně vyplatí do nich nadále investovat.

Druhý den konference zahájil mimořádný host – ukrajinský prezident Viktor Juščenko. Ten ve svém dvacetiminutovém příspěvku poukázal na úspěchy, kterých v poslední době Ukrajina dosáhla, a vyjádřil hluboké přesvědčení, že jeho země vydrží tlak světové krize. Prezident Juščenko zároveň vyzdvihl vztah s EU, který hodnotí jako klíčový, stejně tak snahu Ukrajiny "integrovat se do evropského systému". V průběhu dne se v dalších panelech vystřídali top manažeři předních finančních institucí, aby se podělili s publikem, jak dopady krize pociťují oni a jak se s nimi vyrovnávají. Pozitivním faktem je jistě to, že ať už se jednalo o pojišťovny, bankovní domy nebo finanční poradenství, vesměs byli mluvčí naplnění optimismem v brzkou světlejší budoucnost.

Poslední jednací den se odehrál v rezidenci primátora hlavního města Prahy a byl, jak již je zvykem, věnovaný Rusku a státům SNS. Dopoledne hovořili mluvčí o klíčové roli energií v současném světě a o možnostech a smyslu investic v zemích na východ od nás. Odpolední panel pak byl zasvěcen dopadům našeho a švédského předsednictví na zmíněný region a vzájemné vztahy mezi státy SNS a EU. 💷
